MAT Expansion Program

The Request for Application for the Senate Bill 1029-001 Medication Assisted Treatment Expansion Program was released on July 22nd. This is a continuation of the successful MAT

Expansion Pilot that ran for two years in Pueblo and Routt Counties under the direction of the College of Nursing, University of Colorado Anschutz Medical Campus.

The purpose of the new funds from the Colorado General Assembly is to increase the number of MAT Waivered Providers who provide MAT in clinical organizations or practices in Routt and Pueblo, in the San Luis Valley, (including the counties of Alamosa, Conejos, Costilla, Mineral, Rio Grande, Saguache, Custer and Huerfano), and in up to two additional rural Colorado counties with demonstrated need and capacity development opportunities.

The Center for Prescription Drug Abuse Prevention/Consortium is managing this round of funding working in close partnership with the staff of the College of Nursing.

Enhancing Rural and Frontier Opioid Response Efforts

A grant from COBank, a cooperative bank serving agribusinesses, rural infrastructure providers and Farm Credit associations throughout the United States, in the amount of \$500,000 was awarded to the University of Colorado's Center for Prescription Drug Abuse Prevention/Consortium to fund physician education and other prevention programs in rural and frontier regions of Colorado.

Consortium Annual Meeting

The annual meeting of the Consortium is scheduled for Wednesday October 23rd and will be held on the Anschutz Medical Campus in Aurora. More details are forthcoming.
