### STATE FISCAL YEAR ANNUAL REPORT







The Colorado Substance Exposed Newborns (SEN) Steering Committee envisions a Colorado where a decreasing number of women, children, and families are impacted by substance use during pregnancy and where those who are affected are identified and supported with the appropriate resources, practices, and policies in their communities. The SEN Steering Committee is tasked with identifying and implementing strategies for realizing that vision.

The SEN Steering Committee was established in 2008 and is a subcommittee of the Colorado Substance Abuse Trend and Response Task Force. The SEN Steering Committee exemplifies a collaborative approach to addressing community issues and continues to engage additional partners as appropriate to effectively address program targets.

Beginning its second decade, the SEN Steering
Committee embarked on a new chapter not only for
their efforts but also for their structure. With a set of
2018-2020 priority areas shaped by over 150
stakeholders from around the state in 2017, the SEN
Steering Committee convened, supported, and guided
work groups to advance the six priority areas in 2018. In
State Fiscal Year (SFY) 2019, the SEN Steering
Committee, the Colorado Hospital SEN (CHoSEN)
Collaborative, and the SEN Work Groups shifted their
focus from convening and planning to building
towards impact for Colorado communities.

# BUILDING IMPACT

### PROGRESS BY THE NUMBERS

The Steering Committee reaffirmed commitment from 21 members ranging from medical and behavioral health providers, child welfare professionals, public health experts, family program providers, and policy experts.

## SFY2019 IN REVIEW

#### SEN STEERING COMMITTEE

The Steering Committee convened four times in SFY 2019 to guide the priority area implementation of the SEN work groups, identify and pursue emerging opportunities, and develop an evaluation framework. The Steering Committee has also scheduled an end of 2019 strategic planning meeting to finalize the evaluation framework and begin strategic planning for 2020 and beyond.

#### **FAMILY ADVISORY BOARD**

In SYF2019, the SEN Steering Committee created an Ad-hoc Family Advisory Board (FAB) Work Group to plan the formation of the FAB itself. This group has met monthly since January to develop an FAB logic model and discuss recruitment strategies and FAB logistics, such as potential agenda items and structure. A recruitment postcard was developed by the Work Group, and feedback was provided by treatment providers and people with lived experience in order to inform a final version for distribution. The FAB recruitment postcard has been distributed to SUD treatment and recovery centers, an OB-GYN practice, a maternal mental health practice, and three parenting support groups, including a Circle of Parent support group, Denver Parent Advocates Lending Support (DPALS), and a parent voice council formed through the Office of Early Childhood.

To help inform engagement strategies, a focus group was conducted with mothers, pregnant women, and partners of mothers affected by substance use to better understand key motivators and barriers to participation. All eight participants agreed on the importance of forming a Family Advisory Board and indicated positive overall reactions to the group. Participants identified the strongest motivators for joining the board to include: a child-friendly meeting environment, meal provision, meeting reimbursement, opportunities to impact policy supporting women and families, and board member capacity to define meeting priorities. Participants pinpointed meeting location as it relates to transportation time and feasibility to be the largest potential barrier and advocated for transportation assistance, particularly given participants' preference for in-person versus virtual meetings. In effort to further grow the Family Advisory Board, the focus group findings will serve as strategic recommendations for increasing engagement and retention of board members.

To date, six people have expressed interest in joining the first FAB meeting.

## SFY2019 IN REVIEW

#### CHOSEN COLLABORATIVE

The CHoSEN Collaborative grew to 19 hospitals in the Quality Improvement Track and 49 new Education Track members. 84 members of both tracks came together for a January forum. CHoSEN Collaborative branding guidelines, website, and outreach materials are in development and are set to be finalized in July 2019. 

## SFY2019 IN REVIEW

#### SEN WORK GROUPS

In SFY 2019, each of the SEN Work Groups continued to implement efforts in their identified priority area through monthly meetings and with Illuminate staff support. With the guidance from the Steering Committee, each work group also began to develop the framework for measuring and evaluating their efforts. Across all the work groups, more than 66 Coloradans have participated in driving towards improving the experience of Colorado families impacted by prenatal substance exposure.

#### DATA & RESEARCH WORK GROUP

The Data & Research
Work Group developed a
perinatal data linkage
proposal, funded
through Senate Bill 228,
to link maternal and
infant records from
multiple data sets.

### FASD IDENTIFICATION WORK GROUP

The FASD Identification Work Group designed a gap analysis process, conducted 17 key informant interviews with impacted families and providers, and begun to synthesize initial findings.

#### PLANS OF SAFE CARE WORK GROUP

#### POLICY WORK GROUP

The Policy Work Group shared opportunities to coordinate around stakeholder meetings and met monthly during the legislative session to share policy and implementation updates.

#### PROVIDER EDUCATION WORK GROUP

The Provider Education Work Group is in consultation with a web developer to refine their searchable toolkit platform that contains almost 200 perinatal provider resources.

The SEN Steering Committee and its work groups have an ambitious SFY 2020 ahead of them:

- The Steering Committee will be finalizing and implementing their evaluation framework including evaluation frameworks for each SEN Work Group as well.
- The Family Advisory Board Ad-hoc Work Group and Illuminate
  Colorado staff members will be continuing to recruit members and
  gather feedback from families with lived experience, meeting with
  individuals and groups who express interest in the Family Advisory
  Board. Additionally, the first formal meetings of the FAB itself will
  be planned and convened.
- The CHoSEN Collaborative will be continuing to engage and recruit additional perinatal providers to participate with a particular focus on expanding support for rural and frontier providers.
- The Data and Research Work Group will be operating as an advisory body for the perinatal data linkage project in collaboration with the Colorado Evaluation and Action Lab and the Colorado Consortium for Prescription Drug Abuse Prevention.
- The FASD Identification Work Group will be completing their Gap Analysis report, developing recommendations based on their findings, and disseminating their recommendations.
- The Plans of Safe Care Work Group will be rolling out the Guidelines and Checklist to 18 hospitals, spanning nine Child Welfare regions across the state.
- The SEN Policy Work Group will be developing and refining additional policy priorities.
- The Provider Education Work Group will be promoting their toolkit platform to perinatal health care providers beginning in August 2019.
