**RE:** Public Hearing on September 15, 2021 at 2 p.m. MST via Zoom for Rulemaking under the Colorado Consumer Protection Act and Colorado Antitrust Act

To Whom It May Concern:

The Colorado Consumer Protection Act (“CCPA”) authorizes the Attorney General to “prescribe such forms and promulgate such rules as may be necessary to administer the provisions of” the CCPA. C.R.S. § 6-1-108(1). Similarly, the Colorado Antitrust Act (“CAA”) provides that the Attorney General may “prescribe such forms and promulgate such rules as may reasonably be deemed to be necessary to administer the provisions” of the CAA. C.R.S. § 6-4-110(1)(b).

The Attorney General finds it necessary to propose rules to aid in the efficient and fair administration of the investigative hearing process for matters involving the CCPA and the CAA.
