COLORADO RENT-TO-OWN INITIAL NOTIFICATION FORM
INFORMATION AND INSTRUCTIONS

Rent-to-own companies are regulated under the Rental Purchase Agreements Act of the Colorado Uniform Consumer Credit Code (UCCC).

Rent-to-own companies are required by law to file the notification form and pay the notification fee within 30 days after soliciting or entering into a rental purchase agreement and by January 31 each year, pursuant to § 5-10-804(1)(a) and (b) C.R.S.

Filing Notification

- Start by downloading and saving this packet.
- Use the fill-in fields to type your answers in. Complete the initial notification form and any other applicable lists.

The notification fee is **\$50**.

IMPORTANT LEGAL REQUIREMENTS

Email is our primary method of communication. While we send email reminders for some of the requirements listed below, those reminders are sent as a courtesy, and it is each notification filer’s responsibility to comply with all applicable laws and rules regardless of whether reminders are received.

PLEASE BE AWARE OF RENEWAL REQUIREMENTS! Pursuant to §§ 5-10-804 and 805, C.R.S, retail sellers must file notification and pay the applicable fees annually.

All Rent-to-Own notification filings are valid through each December 31 regardless of the date issued! Renewals must be submitted annually.

Disclosures and Forms: Part 4 of the Rental Purchase Agreement Act requires a lessor to disclose to a lessee various information in a rental purchase agreement. **See §§ 5-10-401 and 402, C.R.S.**

Limitation on Agreements and Practices: Part 5 of the Rental Purchase Agreement Act contains information on limitations on agreements and practices. **See §§ 5-10-501, 502, 503, and 504, C.R.S.**

Limitation on Charges: Part 6 of the Rental Purchase Agreement Act contains information about limitations on charges. **See §§ 5-10-601, 602, 603, and 604, C.R.S.**

Remedies: Part 7 of the Rental Purchase Agreement Act contains information about remedies. **See §§ 5-10-701, 702, 703, and 704, C.R.S.**

Enforcement: Part 8 of the Rental Purchase Agreement Act contains responsibilities of the administrator, including examination or investigation of a lessor's records, and notification requirements **See §§ 5-10-801, 802, 803, 804, and 805, C.R.S.**

Violations and Penalties: Part 9 of the Rental Purchase Agreement Act contains information about violations and penalties. **See §§ 5-10-1001, C.R.S.**

Advertising: Part 10 of the Rental Purchase Agreement Act contains certain advertising requirements. **See §§ 5-10-1001, C.R.S.**

RENT-TO-OWN INITIAL NOTIFICATION
FORM REQUIREMENTS CHECKLIST

A rent-to-own company must file notification and pay the fee within 30 days after commencing business in Colorado.

Completed Form: Send this completed and signed form to the address provided on page 1. Your notification filing will not be considered Active until all the necessary information is received. Please ensure the completeness of your filing to avoid delays.

Notification Fee(s): The notification filing fee (specified on page 1) must be sent, via check, to the address on page 1 with your completed notification form.

Additional Location List: If rental purchase agreements are made someplace other than at the location listed on the initial notification form, provide a complete list of the locations where rental purchase agreements are made.

DBA, Trade or Assumed names: If the applicant uses a DBA or trade name, please ensure the name(s) are properly filed with the Colorado Secretary of State. For more information, contact the Colorado Secretary of State at (303) 894-2200, or go to coloradosos.gov/pubs/business/businessHome.
