Collaborative Process

Beginning in April of 2021 and inspired by members, the Steering Committee and FAB began a process to revisit our language and explore a name change.

- The FAB and Steering Committee engaged in a process to identify ideas and ultimately choose our new name
- Along the way, small ad-hoc groups of Steering Committee and Family Advisory Board members led the thinking
- We offered multiple opportunities for members across the whole effort to weigh in even if they weren't on the FAB or Steering Committee
- Ultimately, FAB and Steering Committee jointly chose the final name, logo, and imagery

We're so grateful and excited to officially launch our new name and logo that was crafted with the input of so many dedicated partners.

SuPPoRT Colorado:

Groups that were previously referred to as the Colorado Substance Exposed Newborns (SEN) Steering Committee, Family Advisory Board, and associated Work/Advisory Groups will be collectively known as:

Supporting Perinatal substance use Prevention, Recovery, and Treatment in Colorado (SuPPoRT Colorado).

Mission and Vision:

SuPPoRT Colorado will continue to work toward the same vision of a *Colorado that equitably serves all families through prevention and reduction of substance use during pregnancy and provides multigenerational support for families to thrive*, **under a name that more accurately reflects our mission, values, and the work we do.**

Our Continued Priorities & Work Groups

- **Fetal Alcohol Spectrum Disorders (FASD):** Build Colorado's statewide capacity to identify Fetal Alcohol Spectrum Disorders and support impacted families.
 - FASD Awareness Work Group
- **Statewide Capacity:** Build Colorado's statewide capacity to align efforts, apply lessons from our data and recognize and respond to emerging needs.
 - Data & Research Advisory Group
 - Policy Analysis Work Group
 - Steering Committee & Family Advisory Board
- **Warm Handoffs:** Ensure systems, and the people who work within them, develop policies and practices with families that support warm handoffs and standardize practices to address inequities
 - Colorado Hospital Substance Exposed Newborns (CHoSEN) Collaborative
 - Plans of Safe Care Work Group.
- **Stigma Reduction:** Reduce stigma around accessing substance use disorder treatment and recovery supports for pregnant and parenting people
 - Family Advisory Board
 - Provider Education Work Group
