She is a 2022 Aspen Institute Ideas Festival Fellow, a published author of academic papers, and writes a monthly column for the Aspen Daily news.

In 2014, Dave was appointed to the powerful Joint Budget Committee (JBC). For four years, he worked with a split party JBC to develop a balanced budget for the State of Colorado. In 2018, Dave ran for State Treasurer and won.

Dave was sworn in as State Treasurer in 2019. He has spearheaded several economic justice initiatives, including Colorado SecureSavings and the CLIMBER Loan Program. Dave is married to State Representative Mary Young, Ph.D. Dave's sister lives in Pueblo.
