## **Notice of Proposed Rulemaking**

Administrator of the Colorado Uniform Consumer Credit Code Concerning the regulation of consumer legal funding transactions, GAP repeal, and UCCC recordkeeping requirements

Date of Notice: April 26, 2024

Date of public hearing: June 3rd, 2024, at 2 pm MT

### I. Hearing Notice

As required by the State Administrative Procedure Act,<sup>1</sup> the Administrator of the Colorado Uniform Consumer Credit Code ("Administrator") gives notice of proposed rulemaking. The hearing is scheduled for June 3rd, 2024, at 2 pm MT. This meeting will be conducted via webinar. Details regarding how to join the webinar and testify during the hearing are outlined in section VI of this notice.

### II. Subject

The Administrator is proposing regulations to consumer legal funding transactions, repealing 4 CCR 902-1:8 ("Rule 8"), and updating UCCC recordkeeping requirements under 4 CCR 902-1:10 ("Rule 10"). This hearing shall concern the proposed rules that follows this notice. Detailed Statements of Basis, Specific Statutory Authority, and Purpose follow this notice and are incorporated by reference.

## III. Statutory authority

The Administrator proposes this rule in accordance with the following statutory provisions:

- rulemaking authority, C.R.S. §§ 5-6-104(1)(e);
- adopting rules for regulating consumer legal funding transactions, C.R.S. § 5-2-204(6);
- permissible additional charges, C.R.S. § 5-2-202(1)(d); and
- record-keeping requirements, C.R.S. §§ 5-2-304, 5-3-109.
