Approximately 30 members of the public attended the meeting at the Durango Public Library, and another four joined virtually.

Open Session

Trustee Weiser called the hybrid meeting (held at the Durango Public Library and via Teams) to order at approximately 3:00 p.m. on May 9, 2024. The meeting's purpose was to brief the Trustees on the current status of issues relating to Natural Resource Damages (NRD) projects, and to request direction and/or approval for various actions.

<u>Agenda</u>

Trustee Gibbs moved to approve the Agenda. Trustee Oeth seconded the motion and the motion was unanimously approved.

Minutes

Trustee Weiser presented the minutes from the January 8, 2024 Trustee Meeting. Trustee Oeth moved to approve the January 8, 2024 minutes. Trustee Gibbs seconded the motion, and the motion was unanimously approved.

Budgets Update

Jennifer Talbert presented the Budgets Update and there were no questions.

Executive Session

Senior AAG Lukas Staks recommended the Trustees make a motion to go into Executive Session to consider Agenda Item #4 on the Trustee Meeting agenda regarding the Home Lake State Wildlife Area. He stated the Executive Session is authorized pursuant to section 24-6-402(3)(a)(II), C.R.S. and other laws that allow the Trustees to enter Executive Session for specific purposes. At approximately 3:05 p.m., Trustee Oeth moved to begin an Executive Session to discuss Agenda Item #4. Trustee Gibbs seconded the motion, and the motion was unanimously approved.

At approximately 3:20 p.m., Trustee Oeth moved to end the Executive Session. Trustee Gibbs seconded the motion, and the motion was unanimously approved, whereupon Executive Session was ended.

Open Session

Trustee Weiser stated that pursuant to statute, the Trustees went into Executive Session to consider Agenda Item #4 regarding the Home Lake State Wildlife Area. The discussion during Executive Session was limited to privileged attorney-client communications about that item. The Executive Session was separately recorded and no decisions were made.

Natural Resource Damages 101

David Banas introduced himself and thanked the community for attending. He briefly explained the role of the Trustees and Trustee staff, and how the NRDs Program works: 1) staff investigates when there is a release of a hazardous substance, and if there are injuries to the State's natural resources, the Trustees and staff attempt to recover damages; and 2) staff works, with input from the community, to restore those injured natural resources by allocating those

funds to project proponents to restore, replace, or acquire the equivalent of the injured resources. Mr. Banas also explained in detail the two distinct parts of the Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA) and the difference between Superfund cleanups that protect human health and the environment by cleaning up contaminated sites and NRD projects that make the public whole by restoring natural resources. He then talked through the procedural steps for a NRDs assessment and restoration.

U.S. Department of Interior (DOI) Natural Resource Damages Regulations

In addition to the roles described by Mr. Banas, Trustee Weiser noted that the Trustees sometimes provide comments to changes in regulations that affect the NRDs Program. Specifically, David Kreutzer presented the Trustees' redlined comments on DOI's regulations concerning more expeditious NRDs calculations. Mr. Kreutzer reported that many other stakeholders, including both plaintiff and defendant sides, shared similar concerns regarding DOI's current procedures.

Suncor

In an effort to touch on various phases of the NRDs Program, Mr. Banas introduced Susan Newton of CDPHE to explain how the Trustees awarded funds stemming from a settlement with Suncor. She described the Suncor incident, injuries, and the cooperative settlement process which resulted in approximately \$2.2 million for restoration projects. Ms. Newton briefly explained the rather complicated Ducks Unlimited project which was habitat-focused and included wetlands mitigation projects in Mexico and Canada to cover the birds' entire flyway and entire lifecycle. She noted that Ducks Unlimited will give a more detailed final report at the next Trustee Meeting on August 15, 2024.

North St. Vrain

Jason King reminded the Trustees of a tanker rollover just north of Lyons in April 2021. The tanker discharged 2,500 gallons of gasoline into the North St. Vrain creek causing a considerable fish kill. Mr. King reported that Trustee staff worked with Abt Associates and presented a NRDs claim to the trucking company's insurers which quickly paid the requested \$240,000. He noted that the Solicitation for Project Proposals (SPP) was issued in January 2024, and only one restoration project proposal was submitted from a collaboration of seven different partners. The project is designed to improve aquatic habitat in the North St. Vrain River in close proximity to the spill site. Mr. King stated that the initial screening of this river restoration project proposal is underway, a site visit is planned for July 2024, and Trustee staff hopes to present a recommendation to the Trustees by the end of 2024.

Memorandum of Understanding with Department of Interior

Ms. Talbert reminded the Trustees about the Memorandum of Understanding (MOU) with DOI which was finalized earlier this year. She reported that the Director of the DOI NRDA Program reached out to her wanting to showcase this MOU for the entire DOI NRDA Program. Ms. Talbert and Emily Splitek (former Trustee staff) will be presenting a webinar in late May about the collaboration and the effectiveness of working together with DOI.

Bonita Peaks Mining District (BPMD)

Trustee Weiser commented that the NRDs Program is on the precipice of some impactful and meaningful NRDs projects in the BPMD. He described three separate "lanes" under CERCLA: (1) Superfund, which focuses on remediation (for example, the harms caused by the Gold King mine blowout); (2) NRDs Program, which focuses on restoration of injured natural resources; and (3) reimbursement to those businesses which were harmed and should receive compensation, noting (1) and (3) are not within the scope of the NRDs Program.

Trustee Weiser explained that restoration work can begin in areas outside the Superfund site before EPA's remediation work at BPMD is completed. He added that the Trustees plan to reserve approximately \$3.5 million for opportunities after EPA's remediation work is completed, leaving up to \$3.5 million in funding that is currently available for NRDs projects. Trustee Weiser informed the community that the Trustees would like project proposals submitted by September 30, 2024, so that the Trustees might be able to act on them in early 2025.

Trustee Oeth commented that an earlier meeting in Silverton helped the Trustees understand some of the projects envisioned, and she noted the community's energetic collaboration. Trustee Gibbs added that he was impressed to see such a large group in attendance and hear about some of the challenges and opportunities related to restoring injured natural resources.

La Plata County Commissioner Marsha Porter-Norton described the harmful impacts of the Gold King mine blowout on the community and the decades of damage to the ecosystem. She expressed excitement about potential projects and noted that the Southern Ute sovereign nation is an important voice going forward as it owns part of the river. Other public comments were made by La Plata County Commissioner Clyde Church, Chara Ragland (Chair of the BPMD Community Advisory Group (CAG)), Ty Churchwell (Trout Unlimited and CAG Executive Committee Member), and Peter Butler (former CAG chairperson).

Mr. King gave a BPMD presentation which explained the NRDs claims, settlements, geographic areas for restoration projects, and an update on the SPP process for BPMD. Mr. Banas clarified the timeline for project proposals.

At approximately 4:30 p.m., Trustee Gibbs moved to adjourn the meeting. Trustee Oeth seconded the motion, and the motion was unanimously approved.
