ESSENTIAL FACTS COMMON TO ALL COUNTS

A. Colorado Lottery

- 1. The Colorado Lottery is an enterprise fund that is part of the Colorado Department of Revenue. The Colorado Lottery is headquartered in Pueblo County, Colorado. The Colorado Department of Revenue is headquartered in Jefferson County, Colorado.
- 2. The Colorado Lottery offers instant-win scratch games where prizes, if any, can be revealed by scratching off an opaque covering on the lottery ticket. Different types of scratch games are offered with different retail values, with some high-value games having a retail value of up to \$50 per ticket.
- 3. Lottery tickets are commonly sold in supermarkets and convenience stores. Colorado Lottery sells scratch games to retailers in packs, with each lottery ticket containing a serialized, 13-digit number that identifies the game number, pack number, and ticket number. When packs arrive at retailers, they are inactive, meaning they cannot be redeemed for their prize value. When a retailer is ready to sell a pack, they scan the back barcode and place the tickets in a specialized dispenser provided by Colorado Lottery. Retailers typically place these dispensers behind the store counter in an area that is supposed to be inaccessible to customers.
- 4. A customer can determine if he or she has a winning ticket by scratching off the covering or by presenting the ticket to a retailer to be validated. Some retailers

offer barcode scanners where customers can validate multiple tickets on their own. Winning tickets with prizes of less than \$600 can be redeemed at a retailer, who will pay out the prize on behalf of Colorado Lottery. Some smaller retailers will not redeem prizes at or above a certain value, such as \$200. Prizes of \$600 or more can only be redeemed at one of four Colorado Lottery claims centers.

B. Criminal Conduct

- 5. Between August 2023 and November 2024, Richard Devon McBee Jr. committed a series of scratch-ticket thefts across eight judicial districts and over twenty cities in Colorado. The aggregate loss from these thefts amounts to over \$175,000.
- 6. Although the thefts occurred on different dates and in different locations, they followed a similar pattern. Whether working on his own or with accomplices—including Brandon Hyatt, Adam Pacheco, David Goetken, and Tawny McCurry—McBee would target gas stations that were staffed by a single store clerk. McBee or his accomplice would then lure the store clerk away from the store's counter. On some occasions, someone would claim that a credit card was stuck in the gas pump. On other occasions, someone would ask for assistance in purchasing a propane tank kept in a locked, outdoor cage. And at other times, someone would spill gasoline on the ground outside.
- 7. While the store clerk was distracted, McBee would sneak behind the counter and steal high-value Colorado Lottery scratch tickets from the store's dispenser. Within hours of the theft, and before the theft was discovered, McBee would enter a different gas station or store to redeem the lottery tickets that he stole elsewhere. McBee did not claim prizes of \$600 or more. After redeeming the winning tickets, McBee would share the illegal proceeds with his accomplices.
- 8. Income from illegal activity is taxable for purposes of Colorado law. Despite earning substantial proceeds from his theft of lottery tickets in 2023, McBee did not file a tax return in that year or report his illegal income.

COUNT 1

 $THEFT - \$20,000 - \$100,000, \ C.R.S. \ 18-4-401(1), \ (2)(h), \ 4(a), \ (6) \ [F4] \ \textbf{08A1G}$

On or about and between August 2, 2023, and September 25, 2023, in the State of Colorado, RICHARD DEVON McBEE JR. unlawfully, feloniously, and knowingly, without authorization or by deception, obtained, retained, or exercised control over a thing of value, namely, prize money of the Colorado Lottery and/or lottery tickets of the 7-Eleven, King Soopers Fuel Center, Fast Market, Rocket, Loaf N Jug, Alta Convenience, and Murphy Express stores identified below, with the value of twenty thousand dollars or more but less than one hundred thousand dollars, and intended to deprive permanently the Colorado Lottery and the 7-Eleven, King

Soopers Fuel Center, Fast Market, Rocket, Loaf N Jug, Alta Convenience, and Murphy Express stores identified below of its use or benefit, in violation of section 18-4-401(1)(a),(2)(h), C.R.S.

The essential facts in support of Count 1 are as follows:

Incident No. 1

(Lot CR: LOT23000370; Grand Jury Exhibit 1, Slides 3-6)

On or August 3, 2023, Richard McBee and Brandon Hyatt entered the Circle K store located at 3185 28th Street in Boulder, Boulder County, Colorado. After Hyatt lured the store attendant outside the store by claiming a credit card was stuck in a gas pump, McBee snuck behind the counter and stole approximately 18 Colorado Lottery tickets with a retail value of approximately \$780.

Within hours of the theft from the Circle K store, McBee validated stolen lottery tickets at the following locations: the Safeway store located at 3325 28th Street, Boulder, Boulder County, Colorado; and the King Soopers store located at 6550 Lookout Road in Boulder, Boulder, County, Colorado. The aggregate amount of prize money paid out by these stores and/or the Colorado Lottery on these stolen lottery tickets was approximately \$920.

The total amount of the stolen Colorado Lottery tickets' retail value and the prize money paid out on those stolen lottery tickets was approximately \$1,700.

Incident No. 2

(Lot CR: LOT23000371; Grand Jury Exhibit 1, Slides 7-10)

On or August 5, 2023, Richard McBee and Brandon Hyatt entered the Circle K store located at 32877 Baseline Rd., Boulder, Boulder County, Colorado. After Hyatt lured the store attendant outside the store by claiming a credit card was stuck in a gas pump, McBee snuck behind the counter and stole approximately 32 Colorado Lottery tickets with a retail value of approximately \$1,590.

Within 24 hours of the theft from the Circle K store, McBee validated stolen lottery tickets at the following locations: the 7-Eleven located at 3334 Arapahoe Road, Erie, Boulder County, Colorado; the Pump & Go store located at 290 North Highway 287 in Lafayette, Colorado; the 7-Eleven store located at 3240 Village Vista Drive, Erie, Colorado; the King Soopers located at 18805 Green Valley Ranch Boulevard, Denver, Colorado; the Gateway Convenience store located at 5910 North Tower Road, Denver, Colorado; and the All in One store located at 19245 East 56th Avenue, Denver, Colorado. The aggregate amount of prize money paid out by these stores and/or the Colorado Lottery on these stolen lottery tickets was approximately \$920.

The total amount of the stolen Colorado Lottery tickets' retail value and the prize money paid out on those stolen lottery tickets was approximately \$2,510.

(Lot CR: LOT23000379; Grand Jury Exhibit 1, Slides 11-14)

On or August 13, 2023, Richard McBee entered the Rocket store located at 3000 28th Street in Boulder, Boulder County, Colorado. After luring the store attendant outside the store by way of a gas-spill distraction, McBee snuck behind the counter and stole at least 48 Colorado Lottery tickets with a retail value of approximately \$2,400.

Within hours of the theft from the Rocket store, McBee stolen lottery tickets at the following locations: the Shortstop Gunbarrel store located at 6510 Lookout Road in Boulder, Boulder County, Colorado; the Conoco store located at 1051 South Hover Road, Longmont, Colorado; the 7-Eleven store located at 841 Ken Pratt Boulevard, Longmont, Colorado; the Everyday store located at 900 Ken Pratt Boulevard, Longmont, Colorado; the 7-Eleven store located at 3914 State Highway 119, Longmont, Colorado; the Quicktrip store located at 3979 Highway 119, Firestone, Colorado; and the Fast Market store located at 505 West 120th Street in Westminster, Colorado. The aggregate amount of prize money paid out by these stores and/or the Colorado Lottery on these stolen lottery tickets was approximately \$1,775.

The total amount of the stolen Colorado Lottery tickets' retail value and the prize money paid out on those stolen lottery tickets was approximately \$4,175.

Incident No. 4

(Lot CR: LOT23000383; Grand Jury Exhibit 1, Slides 15-18)

On or August 14, 2023, Richard McBee entered the 7-Eleven store located at 283 Highway 105, Monument, El Paso County, Colorado. A After luring the store attendant outside the store by way of a gas-spill distraction, McBee snuck behind the counter and stole approximately 35 Colorado Lottery tickets with a retail value of approximately \$1,630.

Within hours of the theft from the 7-Eleven store, McBee stolen lottery tickets at the 7-Eleven store located at 229 Gleneagle Gate View, Colorado Springs, El Paso County, Colorado; the 7-Eleven store located at 1255 Interquest Parkway in Colorado Springs, El Paso County, Colorado; the Fast Market store located at 8105 North Academy Boulevard in Colorado Springs, El Paso County, Colorado; the Loaf N Jug store located at 161 Northgate Boulevard in Colorado Springs, El Paso County, Colorado; and the 7-Eleven store located at 6482 North Academy Boulevard in Colorado Springs, El Paso County, Colorado. The aggregate amount of prize money paid out by these stores and/or the Colorado Lottery on these stolen lottery tickets was approximately \$1,030.

The total amount of the stolen Colorado Lottery tickets' retail value and the prize money paid out on those stolen lottery tickets was approximately \$2,660.

(Lot CR: LOT23000415; Grand Jury Exhibit 1, Slides 19-22)

On or August 27, 2023, Richard McBee and Brandon Hyatt entered the 7-Eleven store located at 229 Gleneagle Gate View in Colorado Springs, El Paso County, Colorado. After luring the store attendant outside the store by way of a gas-spill distraction, McBee snuck behind the counter and stole approximately 59 Colorado Lottery tickets with a retail value of approximately \$2,740.

Within hours of the theft from the 7-Eleven store, McBee validated stolen lottery tickets at the following locations: the Circle K store located at 1190 West Baptist Road, Colorado Springs, El Paso County, Colorado; the King Soopers store located at 1070 West Baptist Road in Colorado Springs, El Paso County, Colorado; and the Kum & Go store located at 1319 Miner Street in Idaho Springs, Colorado. The aggregate amount of prize money paid out by these stores and/or the Colorado Lottery on these stolen lottery tickets was approximately \$3,120.

The total amount of the stolen Colorado Lottery tickets' retail value and the prize money paid out on those stolen lottery tickets was approximately \$5,860.

Incident No. 6

(Lot CR: LOT23000402; Grand Jury Exhibit 1, Slides 23-26)

On or August 28, 2023, Richard McBee entered the 7-Eleven store located at 8 Nottingham Road, Avon, Eagle County, Colorado. After luring the store attendant outside the store by way of a gas-spill distraction, McBee snuck behind the counter and stole approximately 30 Colorado Lottery tickets with a retail value of approximately \$1,140.

Within hours of the theft from the 7-Eleven store, McBee validated stolen lottery tickets at the following locations: the City Market store located at 1410 Grand Avenue in Glenwood Springs, Colorado; the 7-Eleven store located at 51315 Highway 6 in Glenwood Springs, Colorado; the Alta Convenience store located at 51171 Highway 5 and 24, Glenwood Springs, Colorado; and the Kum & Go Mav store located at 2510 Gilstrap Court in Glenwood Springs, Colorado. The aggregate amount of prize money paid out by these stores and/or the Colorado Lottery on these stolen lottery tickets was approximately \$1,210.

The total amount of the stolen Colorado Lottery tickets' retail value and the prize money paid out on those stolen lottery tickets was approximately \$2,350.

Incident No. 7

(Lot CR: LOT23000418; Grand Jury Exhibit 1, Slides 27-30)

On or August 31, 2023, Richard McBee entered the King Soopers Fuel Center located at 1277 Bergen Parkway in Evergreen, Jefferson County, Colorado. After luring the store attendant outside the store by way of a gas-spill distraction, McBee

snuck behind the counter and stole approximately 17 Colorado Lottery tickets with a retail value of approximately \$850.

Within hours of the theft from the King Soopers Fuel Center, McBee validated 19 of the stolen tickets at the Circle K store located at 411 West Florida Avenue in Denver, Colorado and seven of the stolen tickets at the King Soopers store located at 2727 West Evans Avenue in Denver, Colorado. The aggregate amount of prize money paid out by these stores and/or the Colorado Lottery on these stolen lottery tickets was approximately \$1,250.

The total amount of the stolen Colorado Lottery tickets' retail value and the prize money paid out on those stolen lottery tickets was approximately \$2,100.

Incident No. 8

(Lot CR: LOT23000424; Grand Jury Exhibit 1, Slides 31-34)

On or about September 5, 2023, Richard McBee entered the Fast Market store located at 505 West 120th Avenue in Westminster, Adams County, Colorado. After luring the store attendant outside the store by way of gas-spill distraction, McBee snuck behind the counter and stole approximately 42 Colorado Lottery tickets with a retail value of approximately \$2,010.

Within hours of the theft from the Fast Market store, McBee validated stolen lottery tickets at the following locations: the Good 2 Go store located at 107 Laura Court, Dacono, Colorado; the Kum & Go store located at 127 Laura Way, Dacono, Colorado; the Petro Shopping Center located at 2842 SE Frontage Road in Johnstown, Colorado; and the Loves Travel Stop located at 3800 State Highway 56, Berthoud, Colorado. The aggregate amount of prize money paid out by these stores and/or the Colorado Lottery on these stolen lottery tickets was approximately \$1,665.

The total amount of the stolen Colorado Lottery tickets' retail value and the prize money paid out on those stolen lottery tickets was approximately \$3,675.

Incident No. 9

(Lot CR: LOT23000465; Grand Jury Exhibit 1, Slides 35-38)

On or about September 12, 2023, Richard McBee entered the Rocket store located at 12851 West 32nd Avenue in Golden, Jefferson County, Colorado. After luring the store attendant outside the store by way of a gas-spill distraction, McBee snuck behind the counter and stole approximately 37 Colorado Lottery tickets with a retail value of approximately \$1,850.

Within hours of the theft from the Rocket store, McBee validated stolen lottery tickets at the King Soopers store located at 3400 Youngfield Street in Wheat Ridge, Colorado. The aggregate amount of prize money paid out by these stores and/or the Colorado Lottery on these stolen lottery tickets was approximately \$2,000.

The total amount of the stolen Colorado Lottery tickets' retail value and the prize money paid out on those stolen lottery tickets was approximately \$3,850.

Incident No. 10

(Lot CR: LOT23000443; Grand Jury Exhibit 1, Slides 39-42)

On or about September 17, 2023, Richard McBee and Adam Pacheco entered the Loaf N Jug store located at 700 Warner Drive in Golden, Jefferson County, Colorado. After Pacheco luring the store attendant outside the store, McBee snuck behind the counter and stole approximately 13 Colorado Lottery tickets with a retail value of approximately \$610.

Within hours of the theft from the Loaf N Jug store, McBee validated validated stolen lottery tickets at the TravelCenters of America located at 12151 West 44th Avenue in Wheat Ridge, Colorado. The aggregate amount of prize money paid out by these stores and/or the Colorado Lottery on these stolen lottery tickets was approximately \$880.

The total amount of the stolen Colorado Lottery tickets' retail value and the prize money paid out on those stolen lottery tickets was approximately \$1,490.

Incident No. 11

(Lot CR: LOT23000456; Grand Jury Exhibit 1, Slides 43-46)

On or about September 21, 2023, Richard McBee and Adam Pacheco entered the 7-Eleven store located at 21405 East Quincy Avenue in Aurora, Arapahoe County, Colorado. After Pacheco lured the store attendant outside the store by requesting to purchase a propane tank, McBee snuck behind the counter and stole approximately 19 Colorado Lottery tickets with a retail value of approximately \$950.

Within hours of the theft from the 7-Eleven store, McBee validated stolen lottery tickets at the following locations: the K7 G Conoco station located at 18181 East Hampden Avenue in Aurora, Colorado; the 7-Eleven store located at 3005 South Peoria in Aurora, Colorado; and the Kum & Go Mav located at 450 South Santa FE Drive in Denver, Colorado. The aggregate amount of prize money paid out by these stores and/or the Colorado Lottery on these stolen lottery tickets was approximately \$650.

The total amount of the stolen Colorado Lottery tickets' retail value and the prize money paid out on those stolen lottery tickets was approximately \$1,600.

Incident No. 12

(Lot CR: LOT23000461; Grand Jury Exhibit 1, Slides 47-50)

On or about September 22, 2023, Richard McBee and David Goetken entered the 7-Eleven store located at 3790 Wadsworth Boulevard in Wheat Ridge, Jefferson County, Colorado. After Goetken lured the store attendant outside the store by requesting to purchase a propane tank, McBee snuck behind the counter and stole approximately 79 Colorado Lottery tickets with a retail value of approximately \$2,230.

Within hours of the theft from the 7-Eleven store, McBee validated stolen lottery tickets at the following locations: the Circle K store located at 15065 West Colfax Avenue in Lakewood, Colorado; the Kum & Go store located at 18465 West Colfax Avenue in Golden, Colorado; and the TravelCenters of America located at 12151 West 44th Avenue in Wheat Ridge, Colorado. The aggregate amount of prize money paid out by these stores and/or the Colorado Lottery on these stolen lottery tickets was approximately \$1,625.

The total amount of the stolen Colorado Lottery tickets' retail value and the prize money paid out on those stolen lottery tickets was approximately \$3,855.

Incident No. 13

(Lot CR: LOT23000459; Grand Jury Exhibit 1, Slides 51-54)

On or about September 23, 2023, Richard McBee and Adam Pacheco entered the Alta Convenience store located at 15201 East Hampden Avenue in Aurora, Arapahoe County, Colorado. After Pacheco lured the store attendant outside the store by way of a disabled-vehicle distraction, McBee snuck behind the counter and stole approximately 57 Colorado Lottery tickets with a retail value of approximately \$2,570.

Within hours of the theft from the Alta Convenience store, McBee validated stolen lottery tickets at the following locations: the King Soopers located at 18211 East Hampden Avenue in Aurora, Colorado; and the Maverik store located at 21800 East Quincy Avenue in Aurora, Colorado. The aggregate amount of prize money paid out by these stores and/or the Colorado Lottery on these stolen lottery tickets was approximately \$1,740.

The total amount of the stolen Colorado Lottery tickets' retail value and the prize money paid out on those stolen lottery tickets was approximately \$4,310.

Incident No. 14

(Lot CR: LOT23000460; Grand Jury Exhibit 1, Slides 55-58)

On or about September 23, 2023, Richard McBee and Adam Pacheco entered the 7-Eleven store located at 7451 South Gartrell Road in Aurora, Arapahoe County, Colorado. After Pacheco lured the store attendant outside the store by claiming a credit card was stuck in a gas pump, McBee snuck behind the counter and stole approximately 55 Colorado Lottery tickets with a retail value of approximately \$2,460.

Within hours of the theft from the 7-Eleven store, McBee validated stolen lottery tickets at the King Soopers store located at 25701 East Smokey Hill Road in Aurora, Colorado. The aggregate amount of prize money paid out by these stores and/or the Colorado Lottery on these stolen lottery tickets was approximately \$2,430.

The total amount of the stolen Colorado Lottery tickets' retail value and the prize money paid out on those stolen lottery tickets was approximately \$4,890.

Incident No. 15

(Lot CR: LOT23000462; Grand Jury Exhibit 1, Slides 59-62)

On or about September 23, 2023, Richard McBee and Adam Pacheco entered the Murphy Express store located at 21500 East Quincy Avenue in Aurora, Arapahoe County, Colorado. After Pacheco lured the store attendant outside the store by claiming a credit card was stuck in a gas pump, McBee snuck behind the counter and stole approximately 6 Colorado Lottery tickets with a retail value of approximately \$300.

Within hours of the theft from the Murphy Express store, McBee validated a stolen lottery ticket at the Fast Market store located at 15303 East Quincy Avenue in Aurora, Colorado. The aggregate amount of prize money paid out by these stores and/or the Colorado Lottery on these stolen lottery tickets was approximately \$50.

The total amount of the stolen Colorado Lottery tickets' retail value and the prize money paid out on those stolen lottery tickets was approximately \$350.

Incident No. 16

(Lot CR: LOT23000464; Grand Jury Exhibit 1, Slides 63-66)

On or about September 25, 2023, Richard McBee and David Goetken entered the Rocket store located at 5096 South Yosemite Street in Greenwood Village, Arapahoe County, Colorado. After luring the store attendant outside the store by requesting to purchase a propane tank, McBee snuck behind the counter and stole approximately 23 Colorado Lottery tickets with a retail value of approximately \$1,110.

Within hours of the theft from the Rocket store, McBee validated stolen lottery tickets at the following locations: the 7-Eleven store located at 9171 East Arapahoe Road in Englewood, Colorado; and the 7-Eleven store located at 6630 South Yosemite Street in Greenwood Village, Colorado. The aggregate amount of prize money paid out by these stores and/or the Colorado Lottery on these stolen lottery tickets was approximately \$225.

The total amount of the stolen Colorado Lottery tickets' retail value and the prize money paid out on those stolen lottery tickets was approximately \$1,335.

On or about and between September 26, 2023, and October 11, 2023, in the State of Colorado, **RICHARD DEVON McBEE JR.** unlawfully, feloniously, and knowingly, without authorization or by deception, obtained, retained, or exercised control over a thing of value, namely, prize money of the Colorado Lottery and/or lottery tickets of the 7-Eleven, Circle K, Twin Star, Alta Convenience, and Rocket stores identified below, with the value of twenty thousand dollars or more but less than one hundred thousand dollars, and intended to deprive permanently the Colorado Lottery and the 7-Eleven, Circle K, Twin Star, Alta Convenience, and Rocket stores identified below of its use or benefit, in violation of section 18-4-401(1)(a),(2)(h), C.R.S.

The essential facts in support of Count 2 are as follows:

Incident No. 17

(Lot CR: LOT23000471; Grand Jury Exhibit 2, Slides 3-6)

On or about September 26, 2023, Richard McBee and an unknown male accomplice entered the 7-Eleven store located at 8991 East 104th Avenue in Henderson, Adams County, Colorado. After the accomplice lured the store attendant

outside the store by requesting to purchase a propane tank, McBee snuck behind the counter and stole approximately 41 Colorado Lottery tickets with a retail value of approximately \$1,920.

Within hours of the theft from the 7-Eleven store, McBee validated stolen lottery tickets at the King Soopers store located at 750 East 104th Avenue in Thornton, Colorado. The aggregate amount of prize money paid out by these stores and/or the Colorado Lottery on these stolen lottery tickets was approximately \$1,475.

The total amount of the stolen Colorado Lottery tickets' retail value and the prize money paid out on those stolen lottery tickets was approximately \$3,395.

Incident No. 18

(Lot CR: LOT23000478; Grand Jury Exhibit 2, Slides 7-10)

On or about September 27, 2023, Richard McBee and an unknown male accomplice, possibly Adam Pacheco entered the 7-Eleven store located at 23830 East Smoky Hill Road in Aurora, Arapahoe County, Colorado. After Pacheco lured the store attendant outside the store, McBee snuck behind the counter and stole approximately 68 Colorado Lottery tickets with a retail value of approximately \$2,500.

Within hours of the theft from the 7-Eleven store, McBee validated stolen lottery tickets at the King Soopers store located at 4850 East 62nd Avenue in Commerce City, Colorado. The aggregate amount of prize money paid out by these stores and/or the Colorado Lottery on these stolen lottery tickets was approximately \$2.145.

The total amount of the stolen Colorado Lottery tickets' retail value and the prize money paid out on those stolen lottery tickets was approximately \$4,645.

Incident No. 19

(Lot CR: LOT23000479; Grand Jury Exhibit 2, Slides 11-14)

On or about September 28, 2023, Richard McBee entered the Circle K store located at 6802 Wadsworth Boulevard in Arvada, Jefferson County, Colorado. After luring the store attendant outside the store by way of a spilled-gasoline distraction, McBee snuck behind the counter and stole approximately 17 Colorado Lottery tickets with a retail value of approximately \$850.

Within hours of the theft from the Circle K store, McBee validated stolen lottery tickets at the following locations: the TravelCenters of America located at 5101 Quebec Street in Commerce City, Colorado; and the Circle K store located at the 15065 West Colfax Avenue in Lakewood, Colorado. The aggregate amount of prize money paid out by these stores and/or the Colorado Lottery on these stolen lottery tickets was approximately \$550.

The total amount of the stolen Colorado Lottery tickets' retail value and the prize money paid out on those stolen lottery tickets was approximately \$1,400.

Within hours of the theft from the 7-Eleven store, McBee validated stolen lottery tickets at the King Soopers store located at 19711 East Smoky Hil Road in Centennial, Colorado. The aggregate amount of prize money paid out by these stores and/or the Colorado Lottery on these stolen lottery tickets was approximately \$2,002.

The total amount of the stolen Colorado Lottery tickets' retail value and the prize money paid out on those stolen lottery tickets was approximately \$4,362.

Incident No. 21

Within hours of the theft from the 7-Eleven store, McBee validated stolen lottery tickets at the Flying J store located at 16751 East 32nd Avenue in Aurora, Colorado. The aggregate amount of prize money paid out by these stores and/or the Colorado Lottery on these stolen lottery tickets was approximately \$1,030.

The total amount of the stolen Colorado Lottery tickets' retail value and the prize money paid out on those stolen lottery tickets was approximately \$2,260.

Incident No. 22

(Lot CR: LOT23000489; Grand Jury Exhibit 2, Slides 23-26)

On or about October 2, 2023, Richard McBee and Tawny McCurry entered the Twin Star store located at 7995 Wadsworth Boulevard in Arvada, Jefferson County, Colorado. After McCurry lured the store attendant outside the store by claiming a credit card was stuck in a gas pump, McBee snuck behind the counter and stole approximately 35 Colorado Lottery tickets with a retail value of approximately \$428.

Within hours of the theft from the Twin Star store, McBee validated stolen lottery tickets at the following locations: the King Soopers store located at 3400 Youngfield Street in Wheat Ridge, Colorado; and the Kum & Go located at 3432 Clear Creek Drive in Wheat Ridge, Colorado. The aggregate amount of prize money paid out by these stores and/or the Colorado Lottery on these stolen lottery tickets was approximately \$237.

The total amount of the stolen Colorado Lottery tickets' retail value and the prize money paid out on those stolen lottery tickets was approximately \$665.

The aggregate amount of prize money paid out by these stores and/or the Colorado Lottery on these stolen lottery tickets was approximately \$1,655.

The aggregate amount of prize money paid out by these stores and/or the Colorado Lottery on these stolen lottery tickets was approximately \$2,910.

The total amount of the stolen Colorado Lottery tickets' retail value and the prize money paid out on those stolen lottery tickets was approximately \$6,930.

The aggregate amount of prize money paid out by these stores and/or the Colorado Lottery on these stolen lottery tickets was approximately \$1,750.

The total amount of the stolen Colorado Lottery tickets' retail value and the prize money paid out on those stolen lottery tickets was approximately \$4,320.

Within hours of the theft from the Rocket store, McBee validated stolen lottery tickets at the King Soopers located at 4850 East 62nd Avenue in Commerce City, Colorado. The aggregate amount of prize money paid out by these stores and/or the Colorado Lottery on these stolen lottery tickets was approximately \$1,230.

The total amount of the stolen Colorado Lottery tickets' retail value and the prize money paid out on those stolen lottery tickets was approximately \$2,560.

After luring the store attendant outside the store by way of asking to purchase a propane tank, McBee snuck behind the counter and stole approximately 67 Colorado Lottery tickets with a retail value of approximately \$2,850.

Within hours of the theft from the Alta Convenience store, McBee validated stolen lottery tickets at the Love's Travel Stop in 690 Doc Holiday Drive in Cañon City, Fremont County, Colorado. The aggregate amount of prize money paid out by these stores and/or the Colorado Lottery on these stolen lottery tickets was approximately \$1,890.
