CHARGES: 4

COUNT 1: HEALTH-TAMPER W/ WATER SYSTEM, C.R.S. 25-1-114(5)(a),(b)(I) (F3){53021}

COUNT 2: THEFT, C.R.S. 18-4-401(1),(2)(h) (F4){08A1G}

COUNT 3: THEFT, C.R.S. 18-4-401(1),(2)(f) (F6){08A1E}

COUNT 4: TAMPERING WITH PHYSICAL EVIDENCE, C.R.S. 18-8-610(1)(a),(3)(a) (F6){26066}

Matt Karzen, District Attorney for the Fourteenth Judicial District, of the State of Colorado, in the name and by the authority of the People of the State of Colorado, informs the court of the following offenses committed, or triable, in the County of Grand:

COUNT 1-HEALTH-TAMPER W/ WATER SYSTEM (F3)

On or about August 28, 2023, Fabrizio Lorenzin knowingly tampered or attempted to tamper with a public water system, namely: BERTHOUD PASS WATER DITCH, by introducing a contaminant into that public water system or otherwise interfering with the operation of public water system, with the intention of harming persons or the public water system; in violation of 25-1-114 (5)(a), C.R.S.

COUNT 2-THEFT (F4)

On or about August 28, 2023, Fabrizio Lorenzin unlawfully, feloniously, and knowingly, took a thing of value, namely: water, cameras or surveillance equipment, of City of Northglenn, with the value of twenty thousand dollars or more but less than one hundred thousand dollars; in violation of section 18-4-401(1),(2)(h),(6) C.R.S.

COUNT 3-THEFT (F6)

Between and including July 29, 2024 and August 14, 2024, Fabrizio Lorenzin unlawfully, feloniously, and knowingly, took a thing of value, namely: cameras, surveillance equipment, of City of Northglenn, with the value of two thousand dollars or more but less than five thousand dollars; in violation of section 18-4-401(1),(2)(f), (6) C.R.S.

COUNT 4-TAMPERING WITH PHYSICAL EVIDENCE (F6)

Between and including August 28, 2023 and September 18, 2024, Fabrizio Lorenzin, believing that an official proceeding was pending or about to be instituted, and acting without legal right or authority, unlawfully and feloniously destroyed, mutilated, concealed, removed, or altered physical evidence of a felony crime, namely: Theft C.R.S. 18-4-401 and/or Tampering with Public Water System C.R.S. 25-1-114, with intent to impair its verity or availability in the pending or prospective official proceeding; in violation of section 18-8-610(1)(a),(3)(a), C.R.S.

All offenses against the peace and dignity of the people of the State of Colorado.
