The 2013-2014 Colorado State Grand Jurors, chosen, selected and sworn in the name and by the authority of the People of the State of Colorado, upon their oaths, present the following Indictment:

**COUNT NUMBER ONE**

Robbery

C.R.S. § 18-4-301(1) (F4)  
(Chase Bank - Arvada)

On July 25, 2012, in the State of Colorado, Jeffery Eccles unlawfully, feloniously, and knowingly took a thing of value, namely: money, from the person or presence of Chase Bank (8155 Sheridan Blvd., Arvada) by use of force, threats or intimidation; in violation of section 18-4-301(1) C.R.S.

**Facts that support the offense set forth in Count One are set forth after Count Two, and are fully incorporated by reference as if set forth herein.**

**COUNT NUMBER TWO**

Theft (\$1,000)

C.R.S. § 18-4-401(1)(a),(2)(c) (F4)  
(Chase Bank – Arvada)

On July 25, 2012, in the State of Colorado, Jeffery Eccles unlawfully, feloniously, and knowingly obtained or exercised control over a thing of value, namely: money, of Chase Bank (8155 Sheridan Blvd., Arvada) with the value of one thousand dollars or more but less than twenty thousand dollars, without authorization, or by threat or deception, and intended to deprive Chase Bank permanently of its use or benefit; in violation of section 18-4-401(1)(a),(2)(c), C.R.S.

**Facts that support the offenses set forth in Counts One and Two are the following:**

On approxiamtely July 25, 2012, Jeffery Eccles entered Chase Bank at 8155 Sheridan Blvd. in Arvada, Colorado. He walked up to the teller and stated, "This is a robbery." Jeffery Eccles showed the teller a note that stated, "This is a robbery. Give me \$1,500.00." The teller became in fear for her life and obtained cash from a bank cash dispensing maching. While the teller was getting the money, Jeffery Eccles said, "Do it. Do it quick." Jeffery Eccles took the money from the teller and hurriedly walked out of the bank, then ran through the parking lot. The total amount stolen from the bank was \$1,000.00.

**COUNT NUMBER THREE**

Robbery

C.R.S. § 18-4-301(1) (F4)  
(Compass Bank - Englewood)

On August 4, 2012, in the State of Colorado, Jeffery Eccles unlawfully, feloniously, and knowingly took a thing of value, namely: money, from the person or presence of Compass Bank (4600 S. Broadway, Englewood) by use of force, threats or intimidation; in violation of section 18-4-301(1) C.R.S.

**Facts that support the offense set forth in Count Three are set forth after Count Four, and are fully incorporated by reference as if set forth herein.**

**COUNT NUMBER FOUR**

Theft (\$2,130.00)

C.R.S. § 18-5-102(1)(c) (F5)  
(Compass Bank - Englewood)

On August 4, 2012, in the State of Colorado, Jeffery Eccles unlawfully, feloniously, and knowingly obtained or exercised control over a thing of value, namely: money, of Compass Bank (4600 S. Broadway, Englewood) with the value of one thousand dollars or more but less than twenty thousand dollars, without authorization, or by threat or deception, and intended to deprive Compass Bank permanently of its use or benefit; in violation of section 18-4-401(1)(a),(2)(c), C.R.S.

**Facts that support the offenses set forth in Counts Three and Four are the following:**

On approximately August 4, 2012, Jeffery Eccles entered Compass Bank located at 4600 South Broadway in Englewood, Colorado. He walked to the bank teller station and presented a note to a teller that stated, "Robbery!! I need \$2,000 in big bills." The teller responded by getting money from the teller drawer. While the teller was getting the money, Jeffery Eccles said, "Give it all to me." Jeffery Eccles took the money from the teller and walked out of the bank. The total amount stolen from the bank was \$2,130.00.

**COUNT NUMBER FIVE**

Robbery

C.R.S. § 18-4-301(1) (F4)  
(TCF Bank)

On August 11, 2012, in the State of Colorado, Jeffery Eccles unlawfully, feloniously, and knowingly took a thing of value, namely: money, from the person or presence of TCF Bank (7203 W. 55<sup>th</sup> Avenue, Arvada) by use of force, threats or intimidation; in violation of section 18-4-301(1) C.R.S.

Facts that support the offense set forth in Count Five are set forth after Count Six, and are fully incorporated by reference as if set forth herein.

**COUNT NUMBER SIX**

Theft (\$60.00)

C.R.S. § 18-4-401(1),(2)(b) (M2)  
(TCF Bank)

On August 11, 2012, in the State of Colorado, Jeffery Eccles unlawfully and knowingly obtained or exercised control over a thing of value, namely: money, of TCF Bank (7203 W. 55<sup>th</sup> Avenue, Arvada), with the value of less than five hundred dollars, without authorization, or by threat or deception, and intended to deprive TCF Bank permanently of its use or benefit; in violation of section 18-4-401(1)(a),(2)(b), C.R.S.

**Facts that support the offenses set forth in Counts Five and Six are the following:**

On approximately August 11, 2012, Jeffery Eccles walked into TCF Bank located at 7203 West 55<sup>th</sup> Avenue in Arvada, Colorado. He walked to the teller and showed the teller a note that said, "This is a robbery. Give me \$2,000." While the teller read the note, Jeffery Eccles said, "Make it fast." The teller became fearful and started collecting money from the teller drawer. The teller handed Jeffery Eccles one bundle of bait money that contained an electronic GPS tracker. Jeffery Eccles took the money and walked out of the bank through the parking lot. The total amount stolen from the bank was \$60.00.

**COUNT NUMBER SEVEN**

Robbery

C.R.S. § 18-4-301(1) (F4)  
(BBVA Compass Bank)

On April 6, 2013, in the State of Colorado, Jeffery Eccles unlawfully, feloniously, and knowingly took a thing of value, namely: money, from the person or presence of BBVA Compass Bank (7347 Federal Blvd., Westminster) by use of force, threats or intimidation; in violation of section 18-4-301(1) C.R.S.

**Facts that support the offense set forth in Count Seven are set forth after Count Eight, and are fully incorporated by reference as if set forth herein.**

**COUNT NUMBER EIGHT**

Theft (\$2,430.00)

C.R.S. § 18-5-102(1)(c) (F5)

(BBVA Compass Bank)

On April 6, 2013, in the State of Colorado, Jeffery Eccles unlawfully, feloniously, and knowingly obtained or exercised control over a thing of value, namely: money, of BBVA Compass Bank (7347 Federal Blvd., Westminster) with the value of one thousand dollars or more but less than twenty thousand dollars, without authorization, or by threat or deception, and intended to deprive BBVA Compass Bank permanently of its use or benefit; in violation of section 18-4-401(1)(a),(2)(c), C.R.S.

**Facts that support the offenses set forth in Counts Seven and Eight are the following:**

On approximately April 6, 2013, Jeffery Eccles entered the BBVA Compass Bank located at 7347 Federal Blvd. in Westminster, Colorado. He walked to the teller station and showed the teller a note that said, "robbery." The teller became in fear for her life. While the teller was getting money out of the teller drawer, Jeffery Eccles said, "Do it fast." Jeffery Eccles took money from the teller and walked out of the bank. The total amount stolen from the bank was \$2,430.00.

**COUNT NUMBER NINE**

Robbery

C.R.S. § 18-4-301(1) (F4)

(Bank of the West - Denver)

On April 24, 2013, in the State of Colorado, Jeffery Eccles unlawfully, feloniously, and knowingly took a thing of value, namely: money, from the person or presence of the Bank of the West (3102 S. Sheridan Blvd., Denver) by use of force, threats or intimidation; in violation of section 18-4-301(1) C.R.S.

**Facts that support the offense set forth in Count Nine are set forth after Count Ten, and are fully incorporated by reference as if set forth herein.**

**COUNT NUMBER TEN**

Theft (\$2,290.00)

C.R.S. § 18-5-102(1)(c) (F5)

(Bank of the West - Denver)

On April 24, 2013, in the State of Colorado, Jeffery Eccles unlawfully, feloniously, and knowingly obtained or exercised control over a thing of value, namely: money, of Bank of the West (3102 S. Sheridan Blvd., Denver) with the value of one thousand dollars or more but less than twenty thousand dollars, without authorization, or by threat or deception, and intended to deprive Bank of the West permanently of its use or benefit; in violation of section 18-4-401(1)(a),(2)(c), C.R.S.

**Facts that support the offenses set forth in Counts Nine and Ten are the following:**

On approximately April 24, 2013, Jeffery Eccles walked into Bank of the West located at 3102 South Sheridan Blvd. in Denver, Colorado. He walked to the teller station and showed the teller a note that said, "Robbery \$2,500." As he showed the teller the note, Jeffery Eccles stated, "Loose money." The teller took money from the teller drawer and handed it to Jeffery Eccles, who walked out of the bank. The total amount stolen from the bank was \$2,290.00.

**COUNT NUMBER ELEVEN**

Robbery

C.R.S. § 18-4-301(1) (F4)

(Bank of the West - Englewood)

On May 13, 2013, in the State of Colorado, Jeffery Eccles unlawfully, feloniously, and knowingly took a thing of value, namely: money, from the person or presence of the Bank of the West (4301 South Broadway, Englewood) by use of force, threats or intimidation; in violation of section 18-4-301(1) C.R.S.

**Facts that support the offense set forth in Count Eleven are set forth after Count Twelve, and are fully incorporated by reference as if set forth herein.**

**COUNT NUMBER TWELVE**

Theft (\$400.00)

C.R.S. § 18-4-401(1)(a),(2)(b) (M2)

(Bank of the West – Englewood)

On May 13, 2013, in the State of Colorado, Jeffery Eccles unlawfully, feloniously, and knowingly obtained or exercised control over a thing of value, namely: money, of Bank of the West (4301 South Broadway, Englewood) with the value of less than five hundred dollars, without authorization, or by threat or deception, and intended to deprive TCF Bank permanently of its use or benefit; in violation of section 18-4-401(1)(a),(2)(b), C.R.S.

**Facts that support the offenses set forth in Counts Eleven and Twelve are the following:**

On approximately May 13, 2013, Jeffery Eccles entered Bank of the West located at 4301 South Broadway in Englewood, Colorado. He walked to the teller and presented a note that said, "This is a robbery." Jeffery Eccles verbally demanded hundreds, fifties and twenties. Fearing for his safety, the teller complied and gave Jeffery Eccles money from the teller drawer. Jeffery Eccles took the money and walked out of the bank and ran through the parking lot. The total amount stolen from the bank was \$400.00.
