The People, by and through undersigned counsel, in the name and by the authority of the People of the State of Colorado, informs the court of the following offenses committed, or triable, in the County of Douglas:

**COUNT 1-THEFT (F4)**

On or about January 28, 2010, Carter Kimball Lord unlawfully, feloniously, and knowingly obtained or exercised control over things of value, namely: firearms, of the Douglas County Coroner's Office, twice or more within a period of six months, with an aggregate value of one thousand dollars or more but less than twenty thousand dollars, without authorization, or by threat or deception, and knowingly used, concealed, or abandoned the thing of value in such manner as to permanently deprive the Douglas County Coroner's Office of its use or benefit; in violation of section 18-4-401(1)(b),(4), C.R.S.

**COUNT 2-EMBEZZLEMENT OF PUBLIC PROPERTY (F5)**

(Weapon Associated with Douglas County Coroner Case 05-525)

Between and including January 28, 2010 and October 27, 2011, Carter Kimball Lord, a public servant in possession of public monies or public property, the property of the Douglas County Coroner's Office, a political subdivision of the State of Colorado, unlawfully, feloniously, and knowingly converted the public monies or property to his own use or to a use other than the public use authorized by law; in violation of section 18-8-407, C.R.S.

**COUNT 3-EMBEZZLEMENT OF PUBLIC PROPERTY (F5)**

(Weapon Associated with Douglas County Coroner Case 08-438)

Between and including December 2, 2010 and September 20, 2011, Carter Kimball Lord, a public servant in possession of public monies or public property, the property of the Douglas County Coroner's Office, a political subdivision of the State of Colorado, unlawfully, feloniously, and knowingly converted the public monies or property to his own use or to a use other than the public use authorized by law; in violation of section 18-8-407, C.R.S.

**COUNT 4-EMBEZZLEMENT OF PUBLIC PROPERTY (F5)**

(Weapon Associated with Douglas County Coroner Case 09-0105)

Between and including January 28, 2010 and October 27, 2011, Carter Kimball Lord, a public servant in possession of public monies or public property, the property of the Douglas County Coroner's Office, a political subdivision of the State of Colorado, unlawfully, feloniously, and knowingly converted the public monies or property to his own use or to a use other than the public use authorized by law; in violation of section 18-8-407, C.R.S.

**COUNT 5-FORGERY (F5)**

(Douglas County Coroner Case 05-525)

On or about January 28, 2010, Carter Kimball Lord with the intent to defraud the Douglas County Coroner's Office unlawfully, feloniously, and falsely made, completed, altered, or uttered a written instrument which was or which was purported to be, or which was calculated to become or to represent if completed, a written instrument, namely: Firearm Destruction Record and/or Douglas County Coroner's Report, officially issued or created by the Douglas County Coroner's Office, a public office, public servant, or government agency; in violation of section 18-5-102(1)(e), C.R.S.

**COUNT 6-FORGERY (F5)**

(Douglas County Coroner Case 08-438)

On or about December 2, 2010, Carter Kimball Lord with the intent to defraud the Douglas County Coroner's Office, unlawfully, feloniously, and falsely made, completed, altered, or uttered a written instrument which was or which was purported to be, or which was calculated to become or to represent if completed, a written instrument, namely: a firearm disposal record, officially issued or created by the Douglas County Coroner's Office, a public office, public servant, or government agency; in violation of section 18-5-102(1)(e), C.R.S.

**COUNT 7-FORGERY (F5)**

(Douglas County Coroner Case 09-0105)

On or about December 2, 2010, Carter Kimball Lord with the intent to defraud the Douglas County Coroner's Office, unlawfully, feloniously, and falsely made, completed, altered, or uttered a written instrument which was or which was purported to be, or which was calculated to become or to represent if completed, a written instrument, namely: a firearm disposal record, officially issued or created by the Douglas County Coroner's Office, a public office, public servant, or government agency; in violation of section 18-5-102(1)(e), C.R.S.
