PROOF OF IDENTIFICATION

In addition to the signed affidavit of citizenship/legal residency, a copy of one of the following types of identification must be provided:

- ___ Valid Colorado driver license or identification card bearing Applicant's photograph
- ___ Valid driver's license or identification card bearing applicant's photograph issued by a lawful presence state. All states are lawful presence states including the District of Columbia with the exception of:
 - Hawaii, Illinois, Maryland, Nebraska, New Mexico, Utah, and Washington
- ___ U.S. military card or military dependent's identification card
- ___ U.S. Coast Guard Merchant Mariner Card
- ___ Native American Tribal Document
- ___ U.S. naturalization certificate bearing Applicant's intact photograph impressed with the raised embossed seal of the issuing agency
- ___ U.S. certificate of citizenship with bearing Applicant's intact photograph impressed with the raised embossed seal of the issuing agency
- ___ Valid immigration documents demonstrating lawful presence and verified through the Systematic Alien Verification for Entitlements, administered by the U.S. Department of Homeland Security.

If you are unable to provide one of the verifiable forms of identification, a waiver may be requested through the Colorado Department of Revenue.
